The Real Estate Studio in Charleston, SC, is presenting an exhibit of works by local photographer and biologist Sarah Harper Díaz, on view through Nov. 18, 2014.

Díaz is a biologist and wildlife photographer. Her love of birds developed after she volunteered with a local ornithologist and assisted in banding local birds during her undergraduate years at the College of Charleston, where she graduated with a BA in Biology.

Díaz's inspiration for photographing birds began after a study-abroad program that took place in the Peruvian rainforest in 2007. While wandering around the jungle, she explored taking pictures with her Nikon DSLR and decided then and there that she wanted to be a photographer and become fluent in Spanish. Díaz returned to the Peruvian jungle in 2009 where she took an ornithology course and met her husband, Edward Díaz.

From there, Díaz received a Master's Degree in Biology from the Citadel and worked as a research assistant on several projects where she surveyed bird populations in both suburban areas and in the middle of a remote swamp in the heat of


